Type "Define Deadline" into Google and this is what you'll see:

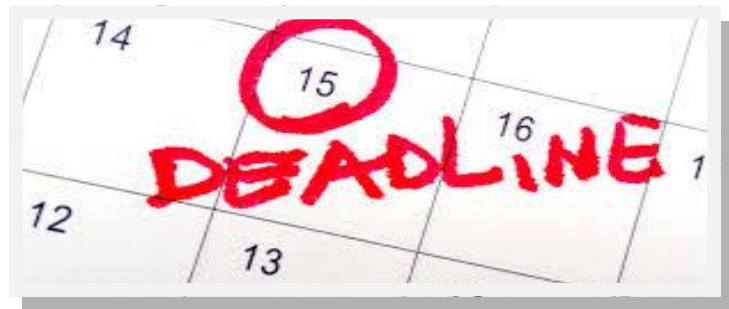
1. "the latest time or date by which something should be completed."

If you are a man, there are a few deadlines you don't want to forget:

1. Your wedding day
2. The anniversary of your wedding day
3. Any day your son or daughter asks you to do something with them

attention. No, you will not be shot, and no, you need not stand beyond any lines. What you will need to do is file your income tax return. The federal government requires all individual income tax returns to be filed by **April 15** (Tuesday).
